

## **“IF YOU KNOW, YOU KNOW(IYKYK)” TERMS AND CONDITIONS (“TERMS”)**

Welcome to the **“IF YOU KNOW, YOU KNOW”** event (“Event”), which expressly include all Activities (defined below), organised by the Hong Kong Science and Technology Parks Corporation (“HKSTP”) which will be held from 26 October – 3 November 2024.

Please read below terms and conditions (“Terms”) carefully and only proceed to participate in the Event if you agree to all the Terms.

### *Eligibility*

1. The Event will include the following activities (collectively “Activities”, each “Activity”):
  - a. uKnow-corn stamp collection;
  - b. InnoMover; and
  - c. Fun Fetch.
2. The Activities are subject to their respective game rules (“Game Rules”) which (i) can be found onsite and on Event’s website (<https://www.hkstp.org/en/park-life/if-you-know-you-know>); (ii) shall form an integral part of the Terms; and (iii) shall not prejudice to the generality of other provisions of the Terms.
3. The Activities are open to the public on a first-come, first-served basis.
4. All participants of the Event (“Participants”) and their Parents/Guardians (where applicable) are deemed to have agreed with the Terms. You shall not proceed to participate in any of the Event if you do not fully agree with the Terms.
5. Participants under the age of fifteen (15) must be accompanied by a Guest aged eighteen (18) or older when they are participating in the Event. To participate in the InnoMover, especially Participants under the age of fifteen (15) must be accompanied by a Guest aged eighteen (18) or older. The supervising adult must supervise the respective children at all times in the Event.

### *Limitations of Liability and Release*

6. HKSTP, its respective affiliates, divisions, subsidiaries, and all of their respective officers, directors, employees, contractors, representatives and agents (collectively the “Released Parties”) will have no liability whatsoever for, and will be released and held harmless by any Participants and/or Parents/Guardians for any claims, liabilities, or causes of action of any kind or nature for any injury, loss or damages of any kind including direct, indirect, incidental, consequential or punitive damages to persons. Without prejudice to the generality of the foregoing, all matters in connection with the Event are provided “as is” without warranty of any kind, either express or implied, including but not limited to, the implied warranties and merchantability, fitness for a particular purpose, and non-infringement.
7. HKSTP shall not be responsible for any damages or losses of personal items/belongings of any Participants.

### *Safety*

8. In addition to the Terms, HKSTP may impose additional safety rules and/or instructions in the Activities (“Safety Rules & Instructions”). All Participants are required to fully comply with all Terms and Safety Rules & Instructions while participating in any of the Activities.
9. All Participants should consider the Activities carefully and any Participants should not participate or stop participating immediately when such Participants have concern or appear that participation in any of the

Activities will cause or is causing any health issues. Without prejudice to the generality of other provisions of the Terms, HKSTP shall not be responsible for any damages caused and/or related to the said health issues.

#### *Warranties, Representations and Agreements*

10. Each Participant and his/her Parent/Guardian (where applicable) represent, warrant, acknowledge and/or agree with the followings:
  - a. All information provided in relation to the Event are complete, accurate and truthful;
  - b. There are no known health issues which may be unsafe for any Activities;
  - c. Acknowledge and agree that the HKSTP may use each Participant's likeness (including but not limited to photos and videos recorded in the Event or during any Activities) for the purpose of promotion and marketing of the Event (including without limitation inclusion of your likeness in any HKSTP's print promotion, social media platforms, HKSTP's campus TV feeds, HKSTP hosted website and Park App) without need of (1) obtaining consent from any Participant and/or Parent/Guardian (where applicable); and (2) providing any additional compensation to any Participants and/or Parents/Guardians (where applicable). For the avoidance of doubt, any intellectual property rights of the said photos and videos shall belong to HKSTP solely; and
  - d. Acknowledge and agree that in addition to the Terms, the privacy policy of HKSTP ("Privacy Policy") is also applicable to the Event. Generally, if Personal Data (as defined in the Privacy Policy) is collected, HKSTP will use such Personal Data for the purposes of (1) registration and enrolments of the Event; and (2) identifying the Participants.

#### *Indemnity*

11. Each Participant and his/her Parent/Guardian agree that they will indemnify and hold the HKSTP and Released Parties harmless on demand from and against all claims, actions liabilities, costs, expenses, loss or damage (including but not limited to consequential losses, loss of profit and loss of reputation and all interest, penalties and legal and other professional costs and expenses) incurred by HKSTP arising from or relating to (directly or indirectly) any default or any violation or breach of any obligations, warranties or representations of such Participant and his/her respective Parent/Guardian under the Terms.

#### *General Rules*

12. HKSTP reserves the right to cancel or make changes to any part of the Event. Should there be cancellations or changes, announcements will be made on the Event's website. If the Event or any part thereof is cancelled for whatever reason, HKSTP will not incur any liability towards any persons arising from or in relation to such cancellation.
13. Arrangements of bad weather conditions are set out in Schedule 1 hereto which are subject to changes to be made by HKSTP in its absolute discretion.
14. Each Participant undertakes not to damage any items in any of the Activities and shall, without prejudice to the generality of other provisions of the Terms, fully indemnify HKSTP for all damages made during his/her participation in the Activities.
15. HKSTP shall have the right to refuse any party to participate in the Event in its absolute discretion.

16. Terms shall include all amendments made by HKSTP from time to time and HKSTP reserves the right to amend any of the Terms in its absolute discretion without notice.
17. Each Participant and his/her Parent/Guardian (where applicable) are not permitted to use the names and/or logos of HKSTP in any manner without the prior written consent of HKSTP.
18. All Participants attending the Event are responsible for their own personal property and HKSTP will not be liable for any loss or damage to any personal property.
19. If any provision contained in the Terms is found to be invalid or unenforceable by any court, the invalid or unenforceable provision shall be severed or amended in such a manner as to render the rest of the provision(s) and remainder of the Terms shall remain valid and enforceable.
20. The Terms shall be interpreted and construed in accordance with the laws and regulations of the Hong Kong Special Administrative Region of the People's Republic of China and any disputes shall be subject to the non-exclusive jurisdiction of the courts of Hong Kong.
21. In case of any discrepancy between the English and Chinese versions of the Terms, the English version shall prevail.
22. The Terms are not intended to be enforceable pursuant to the Contracts (Rights of Third Parties) Ordinance (Cap. 623 of the laws of Hong Kong).

## Game Pass Redemption Terms and Conditions

- Redemption Period:** The redemption period is from 26 October to 3 November 2024 (both dates inclusive). Redemption time is until 15 minutes before the end of event day (redemption hours: Monday to Friday: 10:00 am to 4:45 pm, Saturday to Sunday: 10:00 am to 5:45 pm).
- Redemption Details:** Redemption zones are located at HKSTP Pavilion, G/F, Building 10W. Participants shall present a valid uKnow-corn stamp collection card during the redemption period to redeem game experience(s) (i.e. InnoMover or Fun Fetch).
- Redemption Mechanism:** To enjoy InnoMover or Fun Fetch experience(s), Participants are required to collect at least three (3) uKnow-corn stamps on their stamp collection cards to redeem game pass(es), one (1) game pass per every three (3) stamps. The uKnow-corn stamp collection cards will be stamped with a 'redeemed' chop by the redemption zone staff to signify that the stamp collection cards have been redeemed by the Participants.
- uKnow-corn Stamp Collection Card:** Each Participant can receive up to two (2) stamp collection cards. All uKnow-corn stamp collection cards presented for redemption will not be eligible for exchange. HKSTP reserves the right not to accept and/or recognise any uKnow-corn stamp collection cards which are deemed inappropriate, suspicious and/or invalid for redemption under this promotion at its sole and absolute discretion.
- Game Pass:** Each game pass is only eligible for one (1) game experience. Each Participant shall be eligible to redeem a maximum of three (3) nos. of game passes (either for InnoMover or Fun Fetch) on any given single occasion.
- Quotas:** Daily quotas apply for each game, and redemption is on a first-come, first-served basis while stocks last.
- Non-Exchangeable for Cash:** All uKnow-corn stamp collection cards are not for sale, non-exchangeable for cash and/or other gifts, and are non-returnable.
- General Terms:** Each Participant acknowledges and accepts that HKSTP is at liberty to make any changes or adjustments to the rules and format of this redemption event from time to time without having to give any prior notice. In the event of any disputes arising out of this redemption event, HKSTP shall have the full and final say on all matters concerning the Event.

## InnoMover Terms and Conditions

1. **Age Allowed:** For safety reasons, Participants must be aged eight (8) or above. Participants under the age of fifteen (15) must be accompanied by a Guest aged eighteen (18) or older when they participate in the InnoMover.
2. **Maximum Capacity:** Each session of play for the InnoMover can accommodate up to ten (10) Participants.
3. **No Food and Drinks:** For the sake of safety and hygiene, no consumption and carrying of food (including chewing gum) and/or drinks are allowed inside the perimeters of and on the InnoMover.
4. **Entry Conditions:** Participants should not enter the InnoMover under the influence of alcohol or drugs or while using prescription or non-prescription medication. Before entering the game, all sharp objects must be removed from all Participants to prevent damaging the InnoMover and any related equipment as well as to avoid the risk of injuring the Participants to whom such items belong and of other Participants.
5. **Safety:** Participants may be susceptible to various symptoms and conditions when playing with a virtual reality headset, including:
  - Epileptic seizures or loss of consciousness, involuntary movement or convulsion;
  - Blurred or altered vision;
  - Motion sickness, dizziness, disorientation or nausea; and/or
  - Repetitive motion injuries and eye strain, eye or muscle twitches.

Participants should immediately leave the game and consult your doctor if you experience any of the foregoing symptoms or other discomfort while playing the InnoMover.

6. **Health Conditions:** The following individuals are not recommended to participate in the InnoMover:
  - Pregnant women
  - Individuals with severe acrophobia and vertigo
  - Patients with congenital heart disease and rheumatic heart disease
  - Patients with severe hypertension and vascular diseases
  - Patients with myocarditis and other heart diseases
  - Individuals with coronary artery diseases and severe arrhythmia
  - Diabetics with excessively high or low blood sugar levels
  - Patients with severe epilepsy
  - Individuals with motion sickness after watching 3D images in the past
  - Individuals with other conditions are not suitable for physical activities

HKSTP reserves the right to refuse the entry of any Participants to play the InnoMover on the grounds of safety for the Participant concerned and/or for the safety of other Participants if HKSTP becomes aware of any of the aforesaid conditions affecting any of the Participants.

7. **Queue:** Each Participant must bring along the game pass of the InnoMover to the waiting area at the designated time. If the Participant is up to fifteen (15) minutes late, he/ she can join the queue with the game pass.

Each Participant can only redeem for one (1) game experience per queue. If the Participants hold more than one (1) game pass, they must queue again after each game to ensure fairness.

8. **Parental / Guardian Supervision:** Parents/guardians must supervise their children at all times when their children are participating in this event and shall ensure that their children follow the instructions of HKSTP staff, otherwise, they may be asked to refrain from playing the InnoMover.

9. **Exclusion of Liability:** HKSTP will not be responsible for any injuries sustained or losses incurred by anyone participating in this InnoMover event where such losses or injuries are due to reason(s) that is/are not attributable to the inherent safety of the InnoMover itself or are due to any failure on the part of parents/guardians/participating children to fully heed to or comply with these terms and conditions.
10. **General Terms and Conditions:** Each Participant acknowledges and accepts that HKSTP is at liberty to make any changes or adjustments to the rules and format of this event from time to time without having to give any prior notice. In the event of any disputes arising out of this event, HKSTP shall have the full and final say on all matters concerning this Event.

## Fun Fetch Terms and Conditions

1. **Maximum Capacity:** Each session of play for the Fun Fetch can accommodate up to no more than three (3) Participants.
2. **No Food and Drinks:** For the sake of safety and hygiene, no consumption and carrying of food (including chewing gum) and/or drinks are allowed inside the perimeters of the Fun Fetch.
3. **Gifts:** “Gifts” means a mini uKnow-corn gacha capsule. All gifts that are given out under the Event cannot be returned or exchanged for cash or for other gifts offered under the Event.
4. **No Warranty and Representation:** HKSTP does not make any warranties and representations in relation to the Event or gifts and disclaims all liabilities in relation to the Event or gifts in so far as permitted under the laws of the Hong Kong SAR. All gifts are provided on an “as is” basis.
5. **Queue:** Each Participant must bring along the game pass of the Fun Fetch to the designated waiting area at indicated time. If the Participant is up to fifteen (15) minutes late, he/ she can join the queue with the game pass.

Each Participant can only redeem for one (1) game experience and one (1) mini uKnow-corn gacha capsule per queue. If the Participants hold more than one (1) game pass, they must queue again for next experience to ensure fairness.

6. **Exclusion of Liability:** HKSTP will not be responsible for any injuries sustained or losses incurred by anyone participating in this Fun Fetch event where such losses or injuries are due to reason(s) that is/are not attributable to the inherent safety of the Fun Fetch itself or are due to any failure on the part of parents/guardians/participating children to fully heed to or comply with these terms and conditions.
