Monthly parking will allow users to access the nominated car park 24 hours, 7 days per week, which is popular with people who need unlimited access, and the convenience of a flat monthly rate. 香港科學園區交通及停車場規例

Traffic and Car Parking Regulations in Hong Kong Science Park

一般事項 General

1. 最高車速限制為每小時 8 公里。駕駛者必須以安全速度駕駛。
The maximum speed limit in the Car Parks is 8 km per hour. Drivers must drive at safe speed.
2. 於行人過路處，行人可優先橫過車道。
Pedestrians shall have the right of way at designated pedestrian crossings.
3. (本)停車場使用人士必須遵守所有交通標誌，並遵從香港科技園公司或設施管理處 / 或其僱員指示停泊車輛。
Users of this Car Park must follow all traffic signs and adhere to the instructions of the Hong Kong Science & Technology Parks Corporation (HKSTP) or Facilities Management Office (FMO) and their staff while parking.
4. 香港科技園公司或設施管理處或其僱員不負責在(本)停車場內任何車輛之損毀或任何人士之傷亡事件，不限於使用者之人身損傷或財物損失。香港科技園公司及設施管理處或其僱員無須負責車輛因停泊於(本)停車場內導致之損毀及財物被盜竊之損失，無論因其疏忽或其他任何發生於車場內之事件所導致之任何損失。
HKSTP or FMO and their staff shall not be held liable for any loss of properties or damage to any vehicles or injury or death to any person, not limited to users of this Car Park(s). HKSTP or FMO and their staff is not liable for any damage and theft to cars using this Car Park, nor for negligence or other incidents that may occur in the Car Park(s).

5. 駕駛者應留意(本)停車場的淨空高度限制、裝置及設備，並須對因其疏忽及 / 或過失而導致(本)停車場內的裝置及設備損壞負責。
Drivers should watch out for the headroom limit, fittings and equipment in the Car Parks and be responsible for all damages to the fittings and equipment in the Car Parks due to their negligence and / or fault.
6. 根據法定要求，車主 / 駕駛者於停車後應關掉引擎。如車輛於(本)停車場 / 園區內產生噪音或造成污染，將被要求駛離。
According to statutory requirement the vehicle owner / driver is required to switch off the engine when they leave their vehicle or while waiting. Vehicles causing excessive noise or pollution within the Car Park(s) / Park will be required to leave.
7. 除必要的安全預防措施外，禁止鳴響喇叭或其他警告裝置。
The sound of horns or other warning devices, except as an essential safety precaution, is prohibited.
8. 所有駕駛者均須持有有效駕駛執照。任何學習駕駛者均不得在園區 / (本)停車場駕駛車輛。
All vehicle drivers in the Park shall hold valid driving licenses. No learner driver shall be permitted to drive vehicles in the Park / Car Park(s).
9. 香港科技園公司及設施管理處無責任查驗駕駛人士之身份證明文件及該人士是否已獲授權駕駛該車輛。其駕駛者必須持有有效的駕駛執照及為其車輛購買第三者保險，方可於(本)停車場內駕駛及停泊。
HKSTP and FMO have no obligation to check the identity of drivers, or whether they are authorized to drive the said vehicle. All drivers must have a valid driving license and third party liability insurance when driving or parking at the Car Park(s).
10. 使用者須確保車輛領有有效之保險保障及須經由其保險代理人向其他使用人追討賠償。
All vehicle owners are required to secure their own proper insurance coverage and shall file any claims for compensation by other vehicle users through their own insurers.
11. 停泊在(本)停車場的所有車輛應於擋風玻璃上展示有效的車輛登記許可證，並在車頭及車尾展示登記號碼。香港科技園公司及設施管理處保留扣押 / 拖走任何不符合上述規定的車輛之權利。
All vehicles shall at all times while parked in the Car Parks display a valid vehicle registration licence at the windscreens and registration number plates at the front and rear of the vehicles. HKSTP and FMO reserve all rights to impound / tow away any vehicles which do not comply with the captioned requirements.
12. 指定電動車停車位僅供電動車充電時停泊。所有未經授權停放之車輛可能會被扣押和 / 或拖走，恕不另行通知。
Designated electric vehicle parking space is for the charging by electric vehicles only. All unauthorized parked vehicles may be impounded and / or towed away without prior notice.
13. 除預先得得到香港科技園公司或設施管理處 / 或其僱員准許外，指定之泊車位須停泊指定之車輛。
A licensed parking space is reserved for parking by the designated vehicle(s) only, unless the prior consent of the HKSTP or FMO and their staff has been obtained otherwise.

14. 除得到香港科技園公司或設施管理處 / 或其僱員之指示外，所有車輛必須按照指示及於停車位界線停泊。任何車輛停泊於兩個或以上車位，該車輛將被扣鎖。而該車輛之車主 / 使用者須繳交該等時租車位之費用及本守則第十六項之解鎖費。

All vehicles have to be parked as indicated by the signs and floor marks in this Car Park unless otherwise directed by the HKSTP or FMO and their staff. If the vehicle is parked across two or more parking spaces, it will be impounded and the hourly parking charge for two or more parking spaces shall be levied plus the impounding charge as specified in Clause 16 below.

15. 設施管理處將按香港科技園公司的指示，對違反規定的行為進行以下處理：

- 在車輛擋風玻璃上放置書面警告；及 / 或
- 使用輪箍固定車輛或移動或放置車輛。

Infringements of the regulations shall be dealt with by the FMO under the directives of HKSTP.

- By placing a written warning on the windscreen of the vehicle; and/or
- By immobilizing a vehicle with the application of wheel gaiters, or moving or relocating it.

16. 香港科技園公司及設施管理處保留扣押 / 拖走違反下列規定的車輛之權利：

- 違反停車規定、不當或不誠實地使用停車場；
- 未經授權在限制 / 預留停車場 / 車位停泊；
- 在人行通道或其他非指定車位停泊；
- 停泊造成阻塞；
- 逆線停泊；
- 非電動車輛停泊在指定的電動車充電位；
- 電動車沒有充電或充電完成後停泊在指定電動車充電位；
- 沒有有效之牌照停泊於暢通易達停車位；
- 沒有展示有效的車輛登記牌照。

HKSTP and FMO reserve the right to impound / tow away any vehicles for breaching any of the following regulations:

- Violations of parking regulations, improper or dishonest use of the Car Parks;
- Parking in a restricted / reserved Car Park / parking space without authorization;
- Parking on a pavement OR other non-designated parking space;
- Parking causing obstruction;
- Parking against traffic flow;
- Non-electric vehicle parked at designated EV charging space;
- Electric vehicle parked at designated EV charging space without charging or after charging completion;
- Parked at accessible parking space without valid licence;
- No display valid vehicle registration licence.

17. 車輛放行前將被處以罰款，罰款金額如下：

- 車輛解鎖費用為港幣 320 元
- 拖車費用為港幣 1000 元
- 車輛儲存費用為車輛被拖第 1 天後每天港幣 500 元

A penalty will be levied before releasing the vehicle, the penalty charges are as follows:

- For impounding a vehicle: \$320
- For removing a vehicle: \$1,000
- For storing a vehicle: \$500 for each day after the first day during which the vehicle is impounded.

18. 香港科技園公司及設施管理處不會對因移走或扣鎖車輛而造成的任何車輛損壞負責。
- HKSTP and FMO shall not be liable for any damage to the vehicle occasioned by its removal or immobilization.
19. 香港科技園公司或設施管理處 / 或其僱員保留權利追討導致本停車場設施損毀或損失及任何人身損傷 / 傷亡之車主 / 駕駛者。任何駕駛人士及 / 或車主對園區 / 停車場設施造成損壞，須承擔責任並賠償香港科技園公司修理或更換受損財產的費用。如發生意外，駕駛者應立即向設施管理處（電話：2639 8008）報告。
- HKSTP or FMO and their staff reserve the right to claim compensation against the owner and or / driver of any vehicle who has caused damage, loss or injury to any person in this Car Park(s). Any drivers and / or owners of vehicles causing damage to the Car Park(s) / Park shall bear liability and compensate HKSTP for repair or replacement of the damaged property. In case of accidents, vehicle drivers shall report to FMO (Tel.: 2639 8008) immediately.
20. 除非事先獲得香港科技園公司或設施管理處批准，否則停車位只能用於停泊車輛，不得用作其他任何用途，例如存放貨物或危險物品、車輛維修等。
- Parking spaces should be used for vehicle parking only and not for any other purposes, such as storage of goods or dangerous items, vehicle repairs, etc unless with HKSTP or FMO prior approval.
21. 未經允許商用車輛不可在停車位內裝卸貨品。所有貨物的裝卸只能在指定的裝卸區進行。
- Discharging goods from commercial vehicles in an unauthorized car parking space is not permitted. All loading / unloading of goods should only take place at the designed loading / unloading areas of the Car Parks.
22. 基於安全考慮及避免對車主造成干擾，汽車清潔服務只能由香港科技園公司或設施管理處授權的清潔公司進行，嚴禁未經授權的清潔工或公司於停車場內進行清潔工作。
- For security reasons and to avoid disturbance to the car owners, car cleaning service can only be carried out by a cleaning company authorized by the HKSTP or FMO. Unauthorized cleaners or companies are strictly prohibited.
23. 從消防喉轆使用軟管捲盤取水作非消防用途將違反消防條例及嚴禁使用。香港科技園公司及設施管理處保留向有關當局舉報違規車主的權利。
- Obtaining water from the F.S. hose reel is an infringement of the Fire Services Regulations and is strictly prohibited. HKSTP and FMO reserves the right to report the offending car owners to the Authority concerned.
24. 停車場使用者須對在(本)停車場範圍內因意外或任何其他原因造成的任何人身傷害負責。不得騷擾、威脅或危害停車場內其他車輛、人員及財產的安全。如未經合法授權，任何人士嚴禁調校(改動)或干擾停車場內之其他車輛。
- Car park users shall be responsible for any personal injury inflicted by accident or any other reasons within the car park areas. They shall not disturb, threaten or endanger the security of other vehicles, persons and properties in the Car Parks. No person shall, without lawful authority, tamper with or interfere with other vehicles in the Car Parks.

25. 駕駛者不得作出任何可能對園區造成潛在風險或其他危險或不便的行為。香港科技園公司及設施管理處保留拖走 / 移走任何被認為對園區其他車輛或使用者有潛在危險的車輛之權利。

Vehicle drivers must not do anything that may cause potential risk or other hazard or inconvenience to the Car Park(s) / Park. HKSTP and FMO reserve the right to tow away / remove any vehicle considered to have potential hazard to other vehicles or occupants of the Car Park(s) / Park.

26. 任何車輛如載有根據香港法例第 295 章《危險品條例》所列明之危險物品，被懷疑或有理由相信其足以對其它停泊於車場內之車輛，或其他人士構成危險，該等車輛將不予進入停車場。香港科技園公司或設施管理處 / 或其僱員有權拒絕有關車輛進入(本)停車場或安排移走有關車輛而不作預先通知。

Vehicles carrying dangerous goods to which the Dangerous Goods Ordinance (Cap 295) applies, or is likely to be, in such condition as to be dangerous to any person or other vehicle in car parks, shall not enter the carparks. HKSTP or FMO and their staff reserve the right to deny access or tow away those vehicles without prior notice.

27. 若車輛或其駕駛者違反本規例，香港科技園公司及設施管理處可拒絕車輛進入車場 / 園區。

HKSTP and FMO reserve all rights to allow / refuse a vehicle's entry to the Car Park(s) / Park if it or its driver is in contravention of the Regulations.

28. 請妥善鎖好車輛，不要在車內遺留任何貴重物品。設施管理處不會接受看管任何貴重物品的請求。

Please lock up the vehicles properly and do not leave any valuable items inside the vehicle. FMO shall not entertain any request to look after any valuable items.

29. 車主須保持(本)停車場清潔。

Car owners shall keep the Car Parks clean.

30. 任何對停車場或車場管理人員之投訴，須於事發後一星期內以書面通知香港科技園公司或設施管理處 / 或其僱員。

Any complaint against this Car Park(s) or any of its officers or staff shall be made to the HKSTP or FMO and their staff in writing within 1 week after the occurrence of the incident.

31. (本)停車場使用者如欲將任何車輛拖出停車場，必須先向設施管理處提供書面申請並獲得批准。

Car park users, who want to tow away any vehicles out of the Car Parks, must first apply for prior written approval from the FMO.

時租車輛之車主需特別留意

Specifically Applicable to Hourly Parking Vehicles

32. 如任何車輛的車主或使用人在香港科技園公司或設施管理處 / 或其僱員提出付款要求的七 (7) 天之內仍不繳付本《停車場使用條例》規定應付的任何款項，或者，如果任何車輛在本停車場連續停放三十二 (32) 天或以上，經香港科技園公司或設施管理處 / 或其僱員向該車主或使用人預先七 (7) 天發出售該車輛的通知之後，該車主或使用人仍不將車輛移出本停車場，則該車輛的擁有權將自動歸於香港科技園公司或設施管理處（無需香港科技園公司或設施管理處再行通知或採取任何其他行動），而且香港科技園公司或設施管理處 / 或其僱員在上述通知的七

(7) 天期滿之後，有權按香港科技園公司或設施管理處認為恰當的任何方式（公開投標或拍賣或私下交易或其它方式）出售該車輛及 / 或其附件或內部物件，並以售車所得款項中收回應付給香港科技園公司或設施管理處的款項連同出售手續的一切費用和開支(包括法律費用)。該車輛的停車費應繼續按規定計算和支付，直至該車輛出售之日為止。

On default of payment of any sum payable hereunder by the owner / user of any motor vehicle within seven (7) days of a demand therefore, or in the event of any motor vehicle being parked in this Car Park for a continuous period of thirty-two (32) days or more and the HKSTP or FMO and their staff having given seven (7) days notice of the intention to sell such motor vehicle should the same not be removed from this Car Park, the ownership in the relevant motor vehicle shall automatically (without the need for further notice or any other action on the part of the HKSTP or FMO and their staff) pass to the HKSTP or FMO and their staff who shall upon the expiry of the relevant seven (7) day period the HKSTP or FMO shall be entitled to sell such motor vehicle and / or its accessories or contents by whatever means it deems fit (whether by way of public or private tender, auction or treaty or otherwise) and to recover from the proceeds of sale any money due to the HKSTP or FMO together with its costs and expenses (including legal fees) incurred in connection there with. Parking charges for any period up to the date of sale of such motor vehicle shall continue to accrue and be payable as herein provided.

月租車輛之車主需特別留意

Specifically Applicable to Monthly Parking Vehicles

33. 如駕駛者在駕駛車輛駛出停車場時，香港科技園公司或設施管理處 / 或其僱員有權要求駕駛者出示該車輛之證明文件或有效之科學園智能卡，而在月租權限有效期後產生的一切泊車費用須由該車主 / 車輛使用者負責繳交。

If the driver is driving the vehicle out of the Car Park, the HKSTP or FMO and their staff may be required to produce satisfactory proof of his (her) ownership of vehicle or “HKSP Smart Card”. Payment of all parking charges incurred beyond the monthly licensed period shall be the responsibility of the vehicle owner / user.

34. 月租車位使用者如仍未繳交過期租金，「車牌識別」功能於香港科學園停車場之授權將會被自動終止。停車場業主或設施管理處 / 或其僱員將有權扣鎖有關之車輛，在此情況下，該使用者須繳清所有欠交款項方可駛離(本)停車場。

For monthly licensed users, the access right of their “car plate recognition” will be invalidated when their Car Park licence fee is overdue. Under such circumstances, licensed users have to settle all outstanding car park charges before leaving this Car Park and the Owner of this Car Park or Facilities Management Office and their staff shall have the right to impound their vehicles for such purpose.

35. 任何車輛停泊超逾租用期，該車主 / 使用者須繳交月租費過期日零時零分起計之時租泊車費用。

For any vehicle that has been parked beyond the monthly licensed period, the owner and / or the driver of the vehicle has to pay the charge at the hourly parking rates from the expiry date of the licence before leaving this Car Park(s).

36. 如月租車位使用者未能以「車牌識別」進入本停車場，使用者應使用車場入口處之通話器要求設施管理處協助。

Should a vehicle owner / user fail to gain access into the Car Park using “car plate recognition”, the licensed user is advised to seek the assistance of the Facilities Management Office immediately by pressing the intercom at the Car Park entrance.

37. 如果月租車位使用者在進入或離開(本)停車場時駕駛未註冊的車輛，並且該車輛無法被停車場系統識別以供車輛進出，駕駛者需要向設施管理處提供有效的車輛證明文件。所有額外的停車費用將由車主 / 駕駛者承擔。

If the monthly parking user drives an unregistered vehicle upon entry or exit of the Car Park and, the driver may be required to produce satisfactory proof of his or her ownership of vehicles to the FMO at his or her own cost. All additional parking charges incurred will be borne by the vehicles owner / user.

38. 香港科學園內所有月租停車位只供租予園內公司的租戶或特許持有人的僱員使用。

All monthly car parking spaces at HKSP can only be leased to companies that are tenants or licensees of HKSP (collectively, “Park Companies” and individually, “Park Company”) and are strictly for use by the employees of Park Companies.

39. 車位申請之決定權將根據租戶獲香港科技園公司或設施管理處分配之停車場、車位數量及當時可供出租車位之情況作為考慮因素，香港科技園公司或設施管理處保留最後決定的權利。

Car parking applications shall be considered subject to the number of car parking spaces to which a tenant is entitled and car parking spaces availability. HKSTP or FMO reserves the right to make the final decision.

40. 如發現任何租戶或特許持有人將月租車位租予第三者(包括分租或其它途徑)使用，香港科技園公司或設施管理處有權立即終止有關月租車位的使用權，恕不另行通知。

HKSTP and FMO reserves the right to immediately terminate the use of car parking space(s) by any Park Companies if it is found that or there are grounds suggesting that any such monthly parking space(s) is / are being used (whether by way of sub-letting or by any other means) by third party.

41. 香港科技園公司及設施管理處保留向違反上述(40)的有關公司採取法律行動及追討因其所導致的一切損失及開支的所有權利。

HKSTP and FMO reserve all rights to take legal action against Park Companies that are in violation of (40) above and to recover all losses and expenses that may be incurred as a result of any such violation.

規例修訂 Revision of Regulation

香港科技園公司及設施管理處有權隨時按實際情況，對《香港科學園區交通及停車場規例》進行審查和修改、修訂、新增和刪除，恕不另行通知。

These “Traffic and Car Parking Regulations in Hong Kong Science Park” could be reviewed and revised, amended, added and deleted as and when deemed necessary by HKSTP and FMO without prior notice.

申請程序 Application Procedures

合資格租戶 - 申請指引 For Eligible Tenants - Guidelines for Application

1. 設施管理處收到申請並核實所需文件後，將在 8-10 個工作天內授予申請人泊車權限。
Upon receipt of the application and verification of required documents, Facilities Management Office (FMO) will grant the access right to the applicant within 8-10 working days.
2. 車輛登記文件副本須連同申請表以電子郵件方式提交至 carpark@hksciencepark.org 以供查核。
Copy of Vehicle Registration Document shall be submitted with the application for reference by email to carpark@hksciencepark.org.
3. 月租車位收費：
 - 浮動車位收費 = 港幣 2,200 元/月
 - 電單車位收費 = 港幣 500 元/月Monthly Parking fees:
 - Monthly Floating Parking Fee = HK\$2,200/month.
 - Monthly Motor Cycle Parking Fee = HK\$500/month.
4. 停車場使用有效期限為每月第一天至每月最後一天。
The validity of car park access is from the 1st calendar day to the last day of each calendar month.
5. 不按比例收費，只接受全額月費付款。
No pro-rata rates will be available, only full month payment are accepted.
6. 設施管理處授予申請人泊車權限後，將不會退還(全部或部分)已支付的月費。
After FMO has granted the access right to the applicant, refund (whole or partial) of paid monthly car park fee will not be considered at any time.
7. 所有月租車位使用者必須至少於每月 20 號或之前繳付下一個月之月費，否則設施管理處將會取消泊車權限而不作另行通知。
All parking fees for the following month shall be paid on or before the 20th calendar day of each calendar month. Otherwise, FMO will disable the parking access rights without further notice.
8. 如月租車位使用者停止使用服務或未能依照上述時間表繳付停車費，每月泊車使用權將轉予下個月輪候名單上的下一位申請人，恕不另行通知。
If the monthly car park user stops using the service or fails to settle the parking fee in accordance with the above-mentioned schedule, the monthly parking privilege will go to the next person on the waiting list in the following month without previous notice.
9. 月租車位申請須視乎有權租用的車位數量以及車位的供應情況而定。香港科技園公司保留最終決定權。
Monthly parking application shall be considered subject to the number of car park space entitled, as well as the availability of car parking spaces. HKSTP reserves the right to make the final decision.
10. 停車場使用者和登記車主應承擔所有由設施管理處向有關申請車位追討或索償之欠款或費用。
